## **MULTI-AGE ART OR MUSIC PROGRAM**

Mount St. Joseph University is offering students an opportunity to earn a master's degree and meet the requirements for an Ohio teaching license for those who wish to teach art or music in grades K-12. Students with an undergraduate degree in art or music will be able to earn a Master of Arts degree – Major in Teaching and Multi-Age Licensure.

## **PROGRAM BENEFITS**

- Rolling admissions process
- Evening and weekend classes
- Ability to continue working while attending classes
- Can take up to five years to complete master's degree
- All fieldwork is with highly qualified mentors and supervisors.

## **WHY THIS PROGRAM MAKES SENSE**

- You'll earn your master's degree and be eligible for multi-age licensure (grades K-12) in either art or music, in the state of Ohio. Through reciprocity agreements, you'll also be eligible for licensure in other states.
- Most classes are held in the evenings and on Saturdays to accommodate working adult schedules. Methods classes and clinical placements are during the day.
- Most of our courses include online and in-class components.
- Undergraduate courses from your bachelor's degree may fulfill your content area. In some cases additional content courses may need to be taken.
- You will have hands-on classroom experience.

## GRADUATE EDUCATION PROGRAMS

The School of Education at Mount St. Joseph University offers the following initial licensure programs for those already possessing a bachelor's degree:

- Early Childhood Education – Pre-K through 3rd grade  
Language Arts, Mathematics, Social Studies, Science
- Middle Childhood Education – Grades 4-9  
Language Arts, Mathematics, Social Studies, Science
- Adolescent to Young Adult – Grades 7-12  
Biology, Chemistry, Language Arts, Mathematics, Social Studies, Integrated Science
- Multi-Age Art – Grades K-12
- Multi-Age Music – Grades K-12
- Special Education – Grades K-12

## ADMISSION REQUIREMENTS

Potential students must meet the following requirements:

- A completed graduate application online [msj.edu/apply](https://msj.edu/apply).
- A bachelor's degree from a regionally accredited institution.
- A letter of intent.
- A current résumé.
- Official college transcripts showing a cumulative GPA of no less than 3.0; a GPA below 3.0 requires completion of the GRE.
- Names and contact information for two professional references.
- Acceptable criminal background check.
