MULTI-AGE ART OR MUSIC PROGRAM

Mount St. Joseph University offers students an opportunity to earn a master's degree and meet the requirements for an Ohio teaching license for those who wish to teach art or music in grades K-12. Students with an undergraduate degree in art or music will be able to earn a Master of Arts degree – Major in Teaching and Multi-Age licensure.

WHY THIS PROGRAM MAKES SENSE

You'll earn your master's degree and be eligible for multi-age licensure (grades K-12) in either art or music, in the state of Ohio. Through reciprocity agreements, you'll also be eligible for licensure in other states. Most classes are held in the evenings and on Saturdays to accommodate the schedules of working adults. Methods classes and clinical placements are during the day. Most of our courses include online and in-class components. Undergraduate courses from your bachelor's degree may fulfill your content area. In some cases additional content courses may need to be taken. You will have hands-on classroom experience.

ADMISSION REQUIREMENTS

Potential students must meet the following requirements:

- A completed graduate application online www.msj.edu/apply
- A bachelor's degree from a regionally accredited institution
- A letter of intent
- A current resumé
- Official college transcripts showing a cumulative GPA of no less than 3.0; a GPA below 3.0 requires completion of the GRE
- Names and contact information for two professional references.
