The Catherine Relihan Scholarship is awarded to one eligible student from each cohort who enters the Master of Science in Nursing (MSN - MAGELIN) program.

The scholarship is up to \$4,000 to be distributed over the 4 semesters of the program. Catherine Relihan graduated from College of Mount St. Joseph in 1956 with her Bachelor of Science in Nursing degree. She had a rich career practicing medical-surgical, obstetric and gerontology nursing in her home state of West Virginia before continuing her education in graduate nursing. To be eligible for the Catherine Relihan Scholarship, candidates must:

- be accepted to the MSN - MAGELIN program
- have an admission cumulative GPA or pre-requisite GPA of at least 3.4/4.0
- submit an application
- submit an essay describing your aspirations for personal and professional development in the program

If chosen, candidates will be invited to be interviewed by a selection committee.
